- 7. Paper Mulberry (Broussonetia Papyrifera)
- 8. Cherry Laurel (Prunus Caroliniana)
- 9. Queen Palm (Syagrus romanzoffiana)
- 10. Camphor Tree (Cinnamomum camphora)
